CHAMPIONSHIP:

First and second prizewinners in classes 1,2,3,4,5,6,and 10 are eligible to take part in the championships.

11.. **Driving Class: There is No Entry Fee for this Class**

Geldings and Mares 3yrs old and over pulling a traditional vehicle. Each entry will receive a subsidy of €40.00 to cover the extra cost of bringing a vehicle to the show. Entry Forms must be filled out as normal.

Stillon Parade: (Class 1 Stallions only) *This is a parade not a Show Class.* It is an opportunity to show off your stallion. No Entry Fee.

Entry Fee: **Fee for each Pony in a Class is: €15.00**

RULES OF ENTRY FOR SHOW and (SALE)

1. Applications for the Show/Sale will only be accepted from fully paid-up members of the Kerry Bog Pony Co-Operative Society. **(You may not apply for membership after closing date of entries or on the day of the show in order to enter a pony in the show/sale) Membership Fee: €55.00**
2. **All ponies Must have their Passports with them on the day**
3. The passport must be in the name of the owner otherwise the pony cannot be entered. **(You may not apply for "change of ownership" after the closing date for applications or on the day of the show in order to enter a pony in the show and /or sale). Transfer of Ownership Fee: €15.00**
4. Entry forms details must be completed correctly and signed> **Entries will not be processed if the appropriate fee does not accompany the application, or if the form is incomplete or incorrectly completed or unsigned. Cheques or postal orders must be made Payable to The Kerry Bog Pony Co-Operative Society(Entry Fee for the Show or Sale will not be accepted in Cash).**
5. Entries must reach the Secretary on or before the date stated. No applications will be accepted after the closing date.Only ponies for which applications have been received in time can be shown.
6. Entries in the Kerry Bog Pony National Show will be taken to indicate that the owner completing the application form is willing to abide by the **Rules and Regulations** of The Kerry Bog Pony Co-Operative Society and to accept that the decision of the Judges is final.

LATE ENTRIES WILL NOT BE ACCEPTED UNDER ANY CIRCUMSTANCES THE CLOSING DATE FOR RECEIPT OF ENTRIES IS 2ND AUGUST 2017.

7. All Ponies must be well behaved and presented in show condition. Manes and tails should not be plaited.
8. All ponies MUST be in possession of a PASSPORT. Entries for classes 3,4,5,6,and 10 must have been inspected and classified either Class 1 or Class 2. Stallions in the parade must have been inspected and classified.
9. Only ponies entered in the Show and or / Sale are permitted on the ground on the day.
10. While every care will be taken the Society accepts no responsibility for accidents or disease.

RULES OF ENTRY FOR SALE:

Rules 1,2,3,4,5,8,9,10,11, apply equally to these Rules of Entry of Sale, additionally:-

Vendor's Responsibilities

12. The Vendor is responsible for completing the Sale Entry Form properly and for the accuracy of all information concerning the pedigree description and health of a lot given thereon. (Note:- Details of Foals **when being sold with their Mare** must be given see note at the bottom of the Sale Entry Form)
13. The Vendor, by law, is obliged to declare on the Sale Entry Form, any notifiable disease or stable vice such as Sweet Itch, Ringworm, Crib Biting, Wind Suckin, Box Walking, etc.
14. The Vendor, should make any Pony entered for the sale available for inspection by prospective buyers prior to entering the ring. State if the Mare for sale is "In Foal" (see note at the bottom of the Sale Entry Form).
15. Any dispute arising out of the sale of any Lot in accordance with these Conditions of Sale shall be a dispute between the Vendor and the Purchaser and in **No** circumstances shall the Kerry Bog Pony Co-Operative Society Ltd., be liable to either party in connection with such dispute.

Note: It is the Vendors interest to present his/her Pony/Ponies in pristine Condition.

Purchaser's Duties

16. Purchasers are invited to inspect each Lot prior to purchase.
17. Each Lot is Sold as it stands.
18. There is no term implied in any sale that any Lot is of merchantable quality or is fit for training or any particular purpose.
19. A purchaser has the right to have a Veterinary inspection is carried out on any **LOT** prior to the sale, provided the Vendor's permission is obtained beforehand. A purchase can only be rejected after the sale if they have any notifiable disease(s) not listed by the Vendor.
20. All Lots are sold subject to the Conditions of Sale.
21. Purchases should be paid for on the day, however, the exchange of monies for a purchase is strictly between the Purchaser and the Vendor.
