The Society 2020 Annual Membership Renewal Fee (€35) fell due in January. Upon payment of the annual renewal fees, a member is deemed to be a Kerry Bog Pony Co-operative Society Active Shareholder and is entitled to all member benefits including discounted Kerry Bog Pony Studbook registration and transaction fees from Horse Sport Ireland.

In line with the recently implemented General Data Protection Requirement (GDPR) legislation, the Kerry Bog Pony Co-Operative Society wishes to state that privacy and protection of shareholder data is of paramount importance to us. We are committed to providing clear and transparent explanations of how, when and why your data will be used.

*To comply with the legislation, the Society must have signed data consent from its shareholders on record.*
